

BY-LAW NUMBER 136 OF 2005  
OF THE CITY OF SARNIA

"A By-Law To Establish Fees for Various Business Licences"

WHEREAS Council is empowered to fix fees for the issuance of various business licences pursuant to the Municipal Act, 2001, S. O. 2001, c. 25, as amended;

AND WHEREAS it is necessary and desirable to establish those fees by way of a By-Law.

NOW THEREFORE the Municipal Council of the Corporation of the City of Sarnia enacts as follows:

1. That section 2 of By-Law Number 148 of 2002, as amended, being a by-law respecting the issuance of circus and midway licences, is hereby amended by crossing out "\$390.00" in the third line and replacing it with "\$400.00".
2. That subsection 6(c) of By-Law Number 148 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
3. That section 2 of By-Law Number 149 of 2002, as amended, being a by-law respecting the issuance of licences for Mobile Canteens and Refreshment vehicles, is hereby amended by crossing out "and shall have paid the fee of \$118.00 in the instance of a mobile canteen or \$182.00 in the instance of a refreshment vehicle with respect to such licence" and replacing it with " and shall have paid the fee of \$142.00 in the instance of a mobile canteen or \$190.00 in the instance of a refreshment vehicle with respect to such licence".
4. That subsection 6(c) of By-Law Number 149 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".

5. That subsection 6(c) of By-Law Number 150 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
6. That section 2 of By-Law Number 151 of 2002, as amended, being a by-law respecting the issuance of pawn shop licences, is hereby amended by crossing out "\$115.00" in the third line and replacing it with "\$145.00".
7. That subsection 6(c) of By-Law Number 151 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
8. That section 2 of By-Law Number 152 of 2002, as amended, being a by-law respecting the issuance of public hall licences, is hereby amended by crossing out "\$168.00" in the third line and replacing it with "\$193.00".
9. That subsection 6(c) of By-Law Number 152 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
10. That section 2 of By-Law Number 153 of 2002, as amended, being a by-law respecting the issuance of Victualling house/restaurant licences, is hereby amended by crossing out "\$100.00" in the fourth line and replacing it with "\$142.00".
11. That subsection 6(c) of By-Law Number 153 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
12. That subsection 6(c) of By-Law Number 154 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
13. That section 2 of By-Law Number 155 of 2002, as amended, being a by-law respecting the issuance of auctioneer licences, is hereby amended by crossing out "\$180.00" in the fourth line and replacing it with "\$225.00 with a hall or \$134.00 for an itinerant".

14. That subsection 6(c) of By-Law Number 155 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
15. That section 2 of By-Law Number 156 of 2002, as amended, being a by-law respecting the issuance of licences for lodging houses and bed and breakfast establishments, is hereby amended by crossing out "and shall have paid the fee of \$100.00 with respect to a Bed and Breakfast licence or \$145.00 with respect to a Lodging House Licence" in the third and fourth lines and replacing it with "and shall have paid the fee of \$142.00 with respect to a Bed and Breakfast licence or \$172.00 with respect to a Lodging House Licence".
16. That subsection 6(c) of By-Law Number 156 of 2002, as amended, is hereby amended by crossing out "\$11.00" in the last line and replacing it with "\$12.00".
17. That subsection 6(2)(a) of By-Law Number 157 of 2002, as amended, being a by-law for the licensing, regulating and governing of Adult Videotape Stores, and for regulating videotape stores in which Adult Videotapes are provided, is hereby amended by crossing out "\$117.00" in the first line and replacing it with "\$145.00".
18. That subsection 3 (b) of By-Law Number 158 of 2002, as amended being a by-law licensing and regulating Live Adult Entertainment Parlours and the Advertising for same, is hereby amended by crossing out "\$200.00" in the first line and replacing it with "\$210.00".
19. If any section or sections of this By-Law or parts thereof be found by any court to be illegal or beyond the power of Council to enact, such section or sections or parts thereof shall be deemed to be severable and all other sections or parts of this By-Law shall be deemed to be separate and independent therefrom and continue in full force and effect unless and until similarly found and this By-Law shall be enacted as such.
20. The short title of this By-Law is the "2006 Business Licenses Fees By-Law".

21. This By-Law comes into force and effect upon finally being passed.
