SUBJECT: COVID-19 Update – March 27

The Sarnia Primary Control Group met via teleconference on March 27, 2020 at 9:00am regarding COVID-19 and was notified at that time that the number of infected individuals has increased by 2, bringing the total number of confirmed cases in the Sarnia-Lambton area to 7. Given the rapidly changing situation, we would like to refer concerned community members to the Bluewater Health website for updated information on the COVID-19 Virus, including the number of active cases within our community. https://www.bluewaterhealth.ca/covid-19-information

We thank all community members for their suggestions for dealing with this health emergency and can assure you that, while individual responses may not always be possible given time constraints, all suggestions are being brought forward for consideration by the Sarnia Primary Control Group and referred to relevant professionals who are able to assess and evaluate their effectiveness in helping deal with this emergency.

A suggestion was made by many community members to provide free hotel accommodations to health care practitioners and front line staff who are required to deal with the COVID-19 emergency and are concerned with bringing this virus back home after their shift. The suggestion was referred to Lambton Health who continue to recommend that essential emergency workers maintain their current living arrangements and return home after their shifts. This recommendation is due to the enhanced risks associated with potential community transmissions arising from a lack of capacity to implement proper infection control and safety measures within these private organizations. Given the confirmed presence of the COVID-19 virus within our community, we remind community members that it is essential that we all do our part to stop the spread of this virus by continuing to adopt safe practices such as social distancing, regularly washing our hands and not touching your faces and keeping a safe distance of at least 2 metres from others.

In order to reduce the spread of the COVID-19 virus at the heart of the current pandemic emergency, the Government of Ontario issued a mandatory order requiring that all businesses that have not been identified as an essential workplace be closed as of March 24, 2020 beginning at 11:59 p.m. The list of essential workplaces that can remain open can be accessed from the Government of Ontario web site through the link provided below: https://www.ontario.ca/page/list-essential-workplaces

In order to protect public health, the City would like to remind members of the public to **not use** any of the playground equipment in our local parks because the equipment cannot be properly sanitized at this time. Social distancing and proper hygiene practices are the only ways for us to curb the spread and reduce the burden on the health care system. Too many members of the public are ignoring these recommendations and it is of growing concern to our community.

We would like to reassure members of the public that we are currently continuing to work with our emergency partners to develop enhanced communication protocols to ensure that members of the public continue to have access to the latest up to date information available.
