SUBJECT: COVID-19 Update – May 30

The Sarnia Primary Control Group (SPCG) met via teleconference on May 30, 2020, at 9:00 a.m. regarding developments related to the COVID-19 pandemic.

Lambton Public Health has confirmed that in order to meet the increased testing demand, effective today, drive-through testing is available at the COVID-19 assessment centre located at Sarnia Twin Bridges Nurse Practitioner-Led Clinic.

The drive-through assessment centre at 153 Christina Street will operate at the Front Street entrance of the clinic. Hours of operation are Monday to Thursday from 4:00 p.m. to 8:00 p.m. and Saturdays from 9:00 a.m. to 2:00 p.m. daily.

Appointments are not required to utilize this service and COVID swabs will be performed with people remaining in their vehicles in order to ensure physical distancing is practised.

Individuals who wish to access this service are being asked to approach the driveway from the south end of Front Street with only right turns being allowed into the drive-through centre. Ontario health cards are required however, those without one will not be denied testing.

The City of Sarnia would like to remind our community members that the best way to stop the spread of COVID-19 is by staying home and avoiding

close contact with others outside of your household. It is extremely important to keep in mind the orders and directives that remain in place such as, physical distancing, proper hand hygiene, and not gathering in groups larger than 5 people.

Please note the Provincial Ministry of Health <u>recommends a face mask</u> or covering to reduce the risk of transmission, when physical distancing and keeping a two-meter distance from others may be challenging or not possible, such as traveling on public transit.

The City of Sarnia would like to take this opportunity to thank the community for their ongoing diligence, we recognize that citizens have been tasked with a great amount of responsibility to protect everyone in our community and so far everyone has been doing their part. We appreciate everyone's efforts thus far, and together we will get through this one day at a time.
