


ONTARIO COURT OF JUSTICE

The general penalty provision for the offense indicated above is Section 18.1 of By-Law No. 128 of 2017, **as amended**, a certified copy of which has been filed, and every person who contravenes any provision of this by-law is guilty of an offence and on conviction is liable to a fine as provided for in the *Provincial Offences Act*, R.S.O. 1990, c.P.33, s.61.
