SUBJECT: COVID-19 Update – July 29

The Sarnia Primary Control Group (SPCG) met via teleconference on July 29, 2020, at 9:30 a.m. regarding developments related to COVID-19.

A By-Law to impose temporary regulations requiring the use of masks or face coverings in public indoor spaces in the City of Sarnia will take effect Friday, July 31, 2020. The new By-law requires a mask or face covering to be worn in all enclosed publicly accessible spaces in the city, including all City of Sarnia facilities and Sarnia Transit busses. Some individuals are exempt from wearing a mask. Please remember that not all reasons for exemption are visible. The By-law exempts:

- Children under five years of age
- Persons with an underlying medical condition or disability which inhibits their ability to wear a mask or face covering;
- Persons who are unable to place or remove a mask or face covering without assistance
- Employees or agents of the establishment within an area designated for them and not publicly accessible, or in an area separated by a physical barrier
- Persons who are reasonably accommodated by not wearing a mask or face covering in accordance with the Ontario Human Rights Code
- Persons in an establishment, while receiving services requiring the removal of the face covering, including but not limited to eating or drinking, or while actively engaging in an athletic or fitness activity
- Persons within an establishment, while participating in a religious service, for rituals which require an uncovered mouth

Sarnia-Lambton has seen an increase in positive COVID-19 cases reported over the last week. Residents are reminded to continue practicing public health protection measures including physical distancing, proper hand hygiene, staying home when sick and wearing a mask where required or where physical distancing is not possible. Business owners and staff are not expected to question members of the public not wearing a mask or face covering in their establishment. Customers are not required to provide proof of an exemption. Businesses have the right to create additional standards over and above the Mask By-Law.

A mask or face covering includes a face shield that covers the mouth, nose, and chin. Additionally, a mask or face covering includes a bandana or scarf, that fits securely to the head and is large enough to completely cover the mouth, nose and chin without gapping.

Residents are responsible to supply their own mask or face covering. Some business owners/operators may choose to supply or sell masks but they are not required to do so. If you are attending City Hall and do not have a mask, one will be provided while supplies last. Beginning July 31, 2020, and continuing for a short duration, a limited supply of masks will be available on Sarnia Transit busses at no additional charge.

On August 3, 2020, in recognition of the Civic Holiday, Sarnia City Hall will be closed and Sarnia Transit will not be operating. <u>Garbage collection</u> will take place on August 3 as scheduled.

Starting August 4, 2020 Sarnia Transit will move to modified bus service. Additional information is available online: https://www.sarnia.ca/transit-updates/
