SUBJECT: COVID-19 Update - August 12

The Sarnia Primary Control Group (SPCG) met via teleconference on August 12, 2020, at 9:30 a.m. regarding developments related to COVID-19.

Lambton Kent District School Board's Superintendent of Education, Mark Sherman, provided an update on the return to learn plan for local public elementary and secondary schools. A detailed document on school reopening is scheduled to be distributed publicly by the school board later this week.

Lambton Public Health and Chatham-Kent Public Health, in partnership with local school boards, have prepared a letter for families with information on deciding whether or not to send their children back to school in the fall. You can read the letter on the <u>Lambton Public Health website</u>.

Reg 364/20: Rules for Areas in Stage 3, under the Reopening Ontario (A Flexible Response to COVID-19) Act, 2020, implementing additional measures for restaurants, bars, and other food or drink establishments, as the province carefully and gradually reopens.
