In order to improve physical distancing measures LKDSB has confirmed they have reduced elementary class sizes where able, for students returning to school in September.

As part of Ontario's plan for students to safely return to the classroom in September, the government released <u>today</u> the <u>Operational Guidance:</u> <u>COVID-19 Management in Schools</u> document. This guide was developed in consultation with public health experts, including Ontario's Chief Medical Officer of Health, and aims to help schools identify and isolate COVID-19 cases, reduce the spread of COVID-19 in schools, and prevent and minimize outbreaks.

Residents are asked to place all masks, gloves, paper towels, tissues, wipes and plastic bags in the garbage. Personal Protective Equipment (PPE) does not belong in the blue box or flushed down the toilet. This includes items that have come in contact with the mouth, nose, or eyes of a sick person. The City of Sarnia thanks you for keeping our community safe and clean.

Provincial Updates

Ontario's <u>COVID-19 website</u> includes resources to help stop the spread, sector specific resources, including helpful posters, mental health resources, and other information.

On July 30, 2020 the government released the <u>Guide to Reopening Ontario's Schools</u>, which was developed in consultation with leading medical experts and approved by the Office of the Chief Medical Officer of Health. This plan committed over \$300 million in funding to support the safe reopening of Ontario's schools, which is part of the evolving layers of protection the government is providing to students, parents, staff, and the communities they live and work in.

On August 21 The Province expanded <u>Indoor Capacity for Meeting and Event Facilities</u>. Facilities can have up to 50 guests for each indoor meeting room or event space within the facility. The facility would have to adhere to a plan approved by the Office of the Chief Medical Officer of Health.
