Recognized as a Top 7 Intelligent Community in the World, Lambton County is well known and respected as a key engineering, research, development, and product commercialization centre for the petrochemical and refining industries and is North America’s leading centre for bio industrial manufacturing research and development.

Home to 11 unique municipalities and three First Nations, Lambton County is the birthplace of North America’s oil industry (1858) and today is Canada’s 2nd largest petrochemical cluster. With more than 500,000 acres of cultivated farmland, the area is one of Ontario’s agricultural leaders. A diverse manufacturing sector supports these, and other industries and exports specialized products worldwide.

The award-winning Western Sarnia-Lambton Research Park and Lambton College – ranked one of the top 3 research colleges in Canada – helps Lambton County power innovation across a variety of sectors. On top of being an economic driver for both the Province of Ontario and Country of Canada, Lambton County also offers its residents an unparalleled quality of life.

With over 140km of waterfront that features two internationally recognized Blue Flag Beaches on the shores of Lake Huron and the St. Clair River, Lambton County proudly offers countless opportunities for residents to enjoy the outdoors year-round. The region enjoys a warm climate with more than 230 days of the year seeing temperatures above 0° Celsius and is home to 16 art galleries, eight breweries, wineries, and cider houses, six museums, and three theatres, as well as delicious locally sourced food that can be enjoyed at more than a dozen restaurants along the waters of Lake Huron and the St. Clair River. Lambton County is an exceptional place to live and invest.



Located where Lake Huron connects to the St. Clair River, the City of Sarnia is home to 74,293 residents. The area has a rich history and is known as an important centre for lake freighters and ocean-going ships. Over time, Sarnia became known for its role in the petrochemical sector and today Sarnia has a diverse range of industries.

COMMERCIAL OPPORTUNITIES

The City of Sarnia is home to six business, industrial and research parks that combine for 755 acres of development opportunity suited to service a wide variety of industries. With a vibrant downtown and commercial centres in a stellar location, it is the perfect place to locate your business.

A market threshold analysis was completed along with two community consultations which identified potential demand for additional grocery, travel agency, dry cleaner and restaurant establishments. Additionally, opportunities exist for information technology, creative and professional services industries as well as entertainment/amusement establishments.

The Port of Sarnia can accommodate many of the vessels that are part of the Great Lakes fleet, as well as international vessels moving product through the region. The harbour also provides seasonal berthage, ship repair and maintenance, and a location for the movement of equipment necessary for large scale manufacturing processes. This is an integral component of the Oversized Load Corridor which will further reinforce the Sarnia-Lambton area as a major player in the global marketplace.
