### City of Sarnia – Requirements – Oversize Loads

1. The City requires a copy of a valid insurance certificate with a minimum of \$2,000,000.00 (two million dollars in Canadian currency) naming the City of Sarnia as an Additional Insured and a cross liability clause for any oversized loads.

2. **Fees:**

Two Days' Notice (under 120,000kgs)	\$151
One Day Notice (under 120,000kgs)	\$303
Two Days' Notice (120,000kgs and over)	\$1,300 +10%/axle per load
One Day Notice (120,000kgs and over)	\$2,550 +10%/axle per load

3. The mover shall review the form and obtain all the required signatures for loads 4.15m (13'7") or higher.
