

Vehicle for Hire: Driver's Licence Application

Under the terms of City of Sarnia By-Law 95 of 2023 Licenses Expire 365 days from Date of Issuance

"**Driver's Licence**" is a license authorized by the Licence Manager issued under this Bylaw for the operation of a Vehicle for Hire.

A Driver's License applicant shall meet the following requirements:

- 1. Hold a valid Driver's License issued by the Province of Ontario, designated a Class "G".
- 2. Shall not have accumulated more than nine (9) demerit points under the *Highway Traffic Act* on their driving record at the time of application.
- 3. Shall not have been convicted or found guilty of an offence under the *Highway Traffic Act* regarding moving violations.
- 4. Shall not be entered into the Sex Offender Registry or have a positive match under the Vulnerable Sector Check based upon fingerprints or a known affiliation with an organized crime group.
- 5. Shall not have been convicted or found guilty of any criminal offence or any breach of the Accessibility for Ontarians with Disabilities Act (AODA), 2005, Liquor Licence Act, Highway Traffic Act (moving violations), Compulsory Automobile Insurance Act, or any other Provincial or Federal Statute.
- 6. Proof of Employment from a Taxi Company.
