For all cargo the charges will be forwarded through the agent unless alternate arrangements have been made in writing with the Harbour Operator of the Sarnia Harbour. Any alternate arrangements are subject to approval by Sarnia Harbour, and must be made prior to the arrival of inward bound vessels or the departure of outward bound vessels.
