Describe your Drinking-Water System:

The **Sarnia Distribution System (SDS)** consists of approximately 496 km of watermains, ranging in size from 50mm to 600mm. The system includes approximately 2,700 hydrants, and five automatic flushers. There are no storage tanks or booster pumps within the SDS. Drinking water for the distribution system is supplied, in whole, by the Lambton Area Water Supply System (LAWSS) located in the City of Sarnia on the southern tip of Lake Huron at the headwaters of the St. Clair River.

Sarnia Distribution System is interconnected with neighbouring distribution systems that receive drinking water from LAWSS through closed valves that serve for emergency preparedness (Plympton – Wyoming Water Distribution, Village of Point Edward Water Distribution, and St. Clair Township Water Distribution System). Interconnections with St. Clair Township allow both distribution systems to continuously feed each other when supplementary pressure is required.

Additional interconnections through closed valves to Petrolia Brights Grove Water Treatment Plant and Township of Enniskillen Water Distribution System server for emergency preparedness only.
