

Declaration of Qualifications – Council

Municipal Elections Act, 1996

I, _____, a nominated candidate for the office of:

- Mayor City and County Councillor City Councillor

Further to the Declaration of Qualification completed with the Nomination Paper – Form 1, I acknowledge and do solemnly declare that:

1. I am qualified pursuant to the *Municipal Elections Act* and the *Municipal Act* to be elected to and to hold the above office.
2. Without limiting the generality of paragraph 1, I am at least eighteen (18) years of age, a Canadian citizen, reside in the City of Sarnia or the owner or tenant of land in the City of Sarnia or the spouse of such owner or tenant.
3. I am not ineligible, disqualified or prohibited under the *Municipal Elections Act*, the *Municipal Act*, the *Municipal Conflict of Interest Act*, or any other Act to be elected to or to hold the above office.
4. Without limiting the generality of paragraph 3,
 - I am not an employee of The Corporation of the City of Sarnia, or if I am an employee of The Corporation of the City of Sarnia, I am on an unpaid leave of absence as provided for by section 30 of the *Municipal Elections Act*.
 - I am not the Clerk, Treasurer, Integrity Commissioner, Auditor General, Ombudsman or registrar referred to in section 223.11 of the *Municipal Act* or an investigator of The Corporation of the City of Sarnia referred to in subsection 239.2 (1) of the *Municipal Act*.
 - I do not hold an administrative position of The Corporation of the City of Sarnia.
 - I am not a judge of any court.
 - I am not a member of the Assembly as provided in the *Legislative Assembly Act* or of the Senate or House of Commons of Canada or, if I am such a person, I will provide proof of my resignation in a form satisfactory to the Clerk of the City of Sarnia prior to 2:00 p.m. on Nomination Day, August 21, 2026.
 - I am not a public servant within the meaning of the *Public Service of Ontario Act*, or if I am a public servant, I have followed and will continue to follow and comply with all the relevant provisions of such Act.

- I am not an employee within the meaning of the *Public Service Employment Act* or if I am an employee, I have followed and will continue to follow and comply with all the relevant provisions of such Act.
5. I am not prohibited from voting at the municipal election under section 17 of the *Municipal Elections Act*.
- I am not a person who is serving a sentence of imprisonment in a penal or correctional institution.
 - I am not a corporation.
 - I am not a person acting as executor or trustee or in any other representative capacity.
 - I am not prohibited because of a conviction of a corrupt practice described in subsection 90 (3) of the *Municipal Elections Act*.
6. I am not ineligible for office because of conviction of a corrupt practice under the *Municipal Elections Act* or of an offence under the *Criminal Code (Canada)* in connection with an act or omission that relates to an election to which the *Municipal Elections Act* applies.
7. I am not ineligible from being elected to or holding the above office by reason of any violations of the election campaign financial requirements, violations for not filing the financial statement or any other violations pursuant to the *Municipal Elections Act*.

AND I make this solemn Declaration conscientiously believing it to be true and knowing that it is of the same force and effect as if made under oath and by virtue of the *Canada Evidence Act*.
